



One of the things I love about Sunday morning worship is the music. As we enter into this Easter season, our songs are filled with alleluias and shouts of joy for the victory of Christ over death. As Christ is risen, we too shall rise! Growing up, I always loved the Easter hymns. They were happy, upbeat, joyful. Filled with alleluias and promises of eternal life.

It's also striking that all of this Easter music comes after many weeks of Lent. The Lenten hymns are a bit more somber. I've found over the years that nobody is neutral on Lenten hymns. You either love them or you hate them. Here's the thing, though. I really love the Lenten hymns, too. They speak of a savior who comes to suffer and die in our place. We are the ones who sin, but Christ is the one who receives the punishment in our place. In a sense, that is a happy thing, even if reflecting on the cost is heavy!

This is all to say don't expect me to suddenly encourage us to sing upbeat songs in Lent or somber songs in Easter. We really need to sing both kinds of songs. Somber songs remind us of our sin and upbeat songs remind us of the saving Gospel. To ignore either of those realities is to miss so much of the human condition and how God interacts with it.

#### Jerusalem Evangelical Lutheran Church Council Meeting Minutes for February 15, 2024

#### **Open Forum**

Carol O'Brien reported the following:

- 2025 envelopes have been ordered. Our church name will be printed on the envelope flap (at no extra cost) so they are more easily identifiable when we have a joint service with St. John's.
- Even though the building fund donations are now going into the General Fund, she is able to keep a record of these donations separate in the computer software.
- Young adults (formerly included in their parents' records) should have their own envelopes.
- She is using the Realm computer program to update member information. It also keeps a record of member communion participation.
- Carol suggested several items for our latest move to grow church membership, including availability of an idea sheet at the church, and community outreach by holding a service in the Palmerton Park. Bobby also suggested free community dinners to bring people to the church.

**Correspondence** – We received notice of several grant programs offered by the Synod. Pastor Ken is familiar with these and will keep them in mind when we have events that qualify.

**Secretary's Report** – On motion by Ricky, second by Jackie and voice vote, the January 18 Council minutes and February 4 congregational meeting minutes were approved.

#### Treasurer's Report (Melanie participated via phone conference)

- On motion by Donna, second by Jackie and voice vote, Council authorized Melanie to move \$30,000 from the checking account to the Thrivent money market account.
- Melanie will get details for the question regarding the "reconciliation discrepancy" item listed on the year-end financial report. This will also be reviewed by the auditors.
- Pastor Ken and Melanie will devise a way to report income and expenses in the bulletin.
- Melanie will be moving the balance of the Building Fund and Luther Christman Scholarship Fund accounts into the General Fund checking account, as approved by Council previously.
- We received \$2,000 from the Cemetery Fund towards the cost of liability insurance.
- Jackie informed Melanie that WELCA will pay for event advertising costs to the Times News.
- On motion by Delbert, second by Bobby and voice vote, the Treasurer's Report was approved.

**Financial Secretary's Report** – On motion by Bobby, second by Delbert and voice vote, the Financial Secretary's January 2024 report was approved.

#### Pastor's Report

- Pastor Ken has created a packet to be used by individuals serving in his absence.
- We currently have 6 members in confirmation class (3 first year and 3 second year).
- Organist Frank Hall selects music for services, and Pastor Ken only meets with him when there is a special service.
- Bible study on Habakkuk is being held Wednesday evenings during lent prior to services.
- Council previously discussed reducing the size of Council membership, and Pastor Ken informed the group this can be done via a by-law. He surveyed other churches and found that based on our attendance, the average Council size is 6 members. On motion by Ricky, second by Delbert and voice vote, the membership size for Council was changed to "no less than 6, and no more than 12".
- On motion by Jackie, second by Delbert and voice vote, Pastor Ken's mileage was approved in the amount of \$224.05.

#### **Ongoing and Unfinished Business**

- The office security cameras have been removed, since they record audio as well as video. We haven't been able to find an alternative solution. Joan offered to look into this.
- Our Secretary, Anne, is setting up accounts with vendors to get the best pricing on supplies.
- Melanie is still looking into the bonding of members as she isn't sure our current liability insurance covers this properly.
- Ricky will look into a question raised about correctness of the leaf for the Youngkin Family Estate donation.
- The maintenance plan on our copier will be expiring, and will be canceled since we own the machine. We will continue using it, as it still works, though we will need to shop for toner since it was previously included in the maintenance plan. A new color printer was purchased, and while the mimeograph machine is aged we will continue using it as long as it works.

#### **Personnel Concerns**

• Delbert has found discrepancies in some of the job descriptions. Pastor Ken will review these with the Policy Committee after the Lenten season.

#### Jerusalem Evangelical Lutheran Church Special Council Meeting Minutes from March 10, 2024

**Attendance:** Joan Altemose, Jackie Brotzman, Delbert Christman, Donna McGarry, Ricky Moyer, Connie Smale, Bobby Ziegenfus, and Pastor Melber.

Call to Order by Pastor Melber

Pastor Ken informed the group that our financial secretary and treasurer have been receiving a 1099 for payment of their services rather than a paycheck. This creates additional costs for them at tax preparation time, as well as the need for them to pay for the required social security benefit match. If we choose to issue a paycheck for these positions, it will cost the church approximately \$300 more per year for the FICA match and payroll services. On motion by Connie, second by and voice vote, Council authorized the issuance of paychecks for these services.

We currently pay annual fees for our Microsoft Office program. There is a program available for a one-time purchase at a cost of \$250. The only way to purchase is by use of a credit card and Council is not inclined to get a credit card for the church. Pastor Ken offered to use his credit card, and then be reimbursed for the cost. On motion by Delbert, second by Ricky and voice vote, Council authorized the purchase of this program.
