
WELCA's December meeting included a Christmas Luncheon, held at Bert's Steakhouse in Palmerton.

• Ricky Moyer made a motion to approve this report. Richard Beers seconded the motion. The motion carried. **Financial Secretary's Report** (Motion Required)

• Carol O'Brien made a motion to accept this report. Rolf Windhorn seconded the motion. The motion carried. **Pastor's Report** (Motion required ONLY for **mileage**)

- Carol O'Brien made a motion to approve the Pastor's mileage. Jackie Brotzman seconded motion. The motion carried.
- Ricky Moyer made a motion to accept the five new people noted by the Pastor to join the church. Richard Beers seconded the motion. The motion carried.
- The family of June Strohl would like to make a specific donation to the church.
- Pastor is interested in starting an Altar Guild and will have Stacy put out a sign-up sheet.
- He is interested in weekly Eucharistic Ministers starting January 1, 2023.
- Pastor noted that we will need a person to replace Earl Smale on the Parish committee. Pearl Eckhart has volunteered to fill his vacancy.

• Pastor noted he will be away on November 20, Christ the King Sunday. There will be no communion held on that day. **Stewards for November:**

Ongoing and Unfinished Business for October

- Phone at Luther Hall was not disconnected. Ricky Moyer made a motion to have the phone at Luther Hall disconnected and to give Melanie permission to contact the phone company. Carol O'Brien seconded it. The motion carried.
- Finance committee would like some people from council to meet with the insurance agent to review policies. Rolf & Melanie Windhorn, Ricky Moyer, Richard Beers, Delbert Christman, Bobby Ziegenfus and Pastor will sit on the committee. Melanie will arrange a date and set up the meeting with the team.
- Electric bill went from 12 kwh to 22 kwh.
- At a special meeting held on October 30, Rolf Windhorn presented a spreadsheet depicting multiple providers and their cost per kwh. Carol O'Brien made a motion giving Rolf the authority to cancel our current provider and go back to PPL

immediately. Jackie Brotzman seconded the motion. The motion carried. Further discussion will be held to hear council members views on other providers after they have had a chance to peruse the spreadsheet further.

- At a special meeting held on Sunday, November 6, Ricky Moyer made a motion to go with Rolf Windhorn's recommendation to change electric providers to AEP energy at 0.125 kwh for the church and to go with Direct Energy at .011 kwh for Luther Hall. Richard Beers seconded the motion. The motion carried.
- Ricky Moyer made a motion for Melanie Windhorn to transact business at First Northern Bank. Richard Beers seconded the motion. The motion carried.
- We have collected \$1,358 for Derek Szena. Pastor will attempt to make a visit to deliver the funds.
- Finance noted church cleaning issues. Cleaning under the pews with the vacuum is difficult. They suggested purchasing a robotic vacuum that could be programed to clean under the pews to make the job easier and less time consuming. They also suggested a handheld vacuum to clean the pews. Sandy Christman suggested that certain cleaning jobs could be done once a month. She noted that she called various cleaning services but found them to be expensive or out of our area. Stacy was approached to take on the cleaning position in addition to her clerical obligations, however, she is not interested. Sandy Christman, Shirley Craig, Connie & Earl Smale will prioritize sexton duties. Sandy Christman will be volunteering to clean on Monday at 9:00 and is looking for assistance
- Pastor will make an announcement to start an altar guild.

New Business

- Picnic tables need to be put away at the grove and doors need to be put back on the bandstand. Tuesday, October 25 at 5:00
- Basement job has been completed, but lots of dust needs to be cleaned up.
- Need an outlet outside to plug in a generator if the power goes out.
- We will be discussing the policy for Luther Hall.
- The question of not seeing Thrivent account balances was brought up. Melanie Windhorn will show a balance sheet with Thrivent accounts as Quick books get straightened out. She currently has a statement for \$350,000 but not sure on what account it is. Quarterly reports on Thrivent come to church to Connie Strohl.

Committee Reports:

- **Finance** Carol made a motion to accept the proposed budget which was explained by Pastor Melber. Sandy Christman seconded the motion. The motion carried.
- Richard Beers questioned the status of the Douglas Youngkin estate donation. Carol O'Brien contacted Attorney Martino's office and learned that they are waiting for the acceptance letter from the IRS. When it arrives, the estate will be settled, and the estate executer will be notified. At that point the executer will disperse the funds.
- Music & Worship There will be no Thanksgiving eve service.

- **Outreach** Sandy Christman stated that no one came to the last meeting. They will continue to send out cards. There has been no future meeting scheduled.
